**This agreement is valid from May 1st - October 15th of the current year.**

- All camping units must be approved by the campground director.
- This Membership cannot be transferred. No refunds for early departure.
- This agreement is for camping and wrist bands, no meals are included.
- ALL ATVS, golf carts, and other recreational motorized vehicles must be registered by Wesleyan Woods campground. You must follow all ATV rules.
- Membership is for immediate household(living in your home) family members only. If you have more than 5 people living in your house there will be an additional \$50 per person per camp season for the 6th, 7th, 8th person.
- Grandchildren are welcome to stay over night, as long as there is NOT more than 8 people total on a site.They must register with the front office. There is a \$5 per person per night fee. This fee does NOT cover activity band.
- All Wesleyan Woods Camp rules must be followed. (Located on the back of this paper)
- All State of Michigan laws and camping rules must be followed.
- The breaking of Wesleyan Woods Camp rules or State of Michigan laws may result in the termination of this agreement without a refund of monies paid.
- Participation with any groups that will be on the grounds is NOT ALLOWED.
- In the event where the camp would be rented out entirely by a group, a background check would be required.
- No illegal activities, drugs, alcohol, firearms, fireworks, or immoral activities allowed on the grounds at any time. Termination for any of these reasons will result in the forfeit of monies paid.
- In case this agreement is terminated for any reason, you must vacate the premises immediately. However, you will have one week to remove your RV before Wesleyan Woods Camp has it removed at the owner's expense.
- You are allowed a maximum of two vehicles to be parked on your campsite, all other vehicles should be parked in the parking lot. Do not park on empty campsites.
- Dumpsters are available for normal trash dumping.
- Your campsite is to always be kept neat and clean
  - You are responsible to keep the grass mowed. You may use the push mower located in the hanger.
  - No sheds are allowed on campsite (any permanent or temporary structure that has a roof, walls, doors, & can be walked into).
  - Any changes made to the campsite or adding structures must be approved in writing by the director.
- Base Seasonal fees DO NOT include the following: The following extras can be added to the base seasonal fees.
  - \$25 monthly to run air conditioning unit while you are gone.
  - \$25 monthly to run a freezer or other additional outside electric appliance regardless if you are there or not.
  - \$20 fee each time the campground has to mow your campsite as needed.
  - RV Winter storage fee \$25 a month or ON-ASSIGNED-SITE winter storage fee \$35 month
- To keep your current site for the following camping season, \$100 non-refundable deposit is required by October 1st and your request to be a seasonal again must be approved by the camp director.
- To change sites the following camping season a \$100 non-refundable deposit & site change application is required by October 1st. The site changes will be processed according to the order they were received. The results will be processed starting the first Monday in November.

- I, the customer/participant understand that the ropes course is a hazardous activity. I understand that the ropes course activity involves a risk of injury and even death and caution is required. Risks include but are not limited to: falling resulting in rope burns, abrasions, and pulled muscles. I hereby assume and accept any and all risks of injury or damage while participating at Wesleyan Woods Camp ropes course facility. Among other safety precautions I understand the need to climb only while wearing a climbing harness which is attached to a safety rope while being belayed by a trained belayer. I represent to Wesleyan Woods Camp that I have the skills and ability to safely participate in the ropes course activity.
- The swimming water is tested regularly. However, you are swimming at your own risk concerning sickness, personal injuries and death.
- In consideration of my being permitted by Wesleyan Woods Camp to participate in the ropes course and activities connected with the ropes course; I, for myself, my heirs, successors and personal representatives hereby release and discharge Wesleyan Woods Camp, its officers, board members, and employees from any and all claims, actions, suits, and proceedings, costs, expenses, injuries or damages to myself.
- I agree to obey the rules for all activities including but not limited to; the use of guns, archery, paintball field, swimming, water slide, wet zip line, dry zip line, hayrides, etc.
- Canoe & Boats; I agree to obey all of Wesleyan Woods Camp canoe rules. All persons in canoes must have a life jacket on, children under 16 must be accompanied by an adult. All life jackets and oars must be returned to the boat house or camp staff.
- I, as parent &/or legal guardian, give Wesleyan Woods Camp permission for the use of photographs and/or video including my son/daughter to be used in camp publicity.
- I agree to obey the State of Michigan and Wesleyan Woods Camp ATV/ORV rules and pay for any damages, other than wear and tear, that my vehicle might cause. I accept responsibility for any body injury to myself or others that I might cause.
- I agree for myself and heirs, guardians, and legal representatives, that in the event of any claims for personal injury, death, property damage, shall be prosecuted against Wesleyan Woods Camp, I shall indemnify and save harmless Wesleyan Woods Camp, its officers, board members, employees, and its affiliated organization from any and all such claims or causes of action by whom ever made and whenever presented.
